4. Presentation by Chief Snyder recognizing Officer Judi Ellis for her many years of volunteer service to the City of Manor. Officer Ellis resigned from the position of Code Enforcement Officer, effective July 3rd.

Chief Robert Snyder recognized Officer Judi Ellis's 14 years of service with the City of Manor.

5. Consideration and possible action on a letter of censure from the City Council, addressed to Jeff Turner.

Councilmember Davies wrote a letter regarding the censure and she presented to Council and Mr. Turner. She read the letter. No action taken.

6. Discussion and possible action on the Chamberlain House project, as requested by Councilmember Burrell.

Councilmember Hooker stated that this is causing issues and that Council should make a decision on what should be done. Councilmember Davies stated that there are not enough HOT funds available to complete the project but the structural issues could be addressed. Councilmember Burrell made a motion to progress with the Chamberlain house and to form a committee to supervise the reconstruction. Motion was not seconded. Discussion was held. Motion to form a committee, consisting of Councilmember Burrell, Councilmember Davies and City Manager Steve Shanks to look into all options for the Chamberlain house by Councilmember Turner. Seconded by Councilmember Hooker. Vote: 6 For – 1 Against. Councilmember Burrell voted Against.

7. Discussion and possible action on the budgeting for two additional police department positions, as requested by Councilmember Burrell.
