2. Motion to accept the Annual Audit of the Basic Financial Statements of the City of Manor, Texas was made by Councilmember Davies. Seconded by Councilmember Hooker. Vote: 7 For – 0 Against.

Motion to accept the departmental reports was made by Councilmember Davies. Seconded by Councilmember Cruz. Vote: 7 For – 0 Against.

6. Consideration, discussion and possible action on award of a construction contract for the Manor Police Station & Wastewater Treatment Plant Site Improvements project.

Councilmember Turner and Councilmember Snowden announced that they would be recusing themselves from this agenda item. Frank Phelan, City Engineer introduced the bid information received. The lowest bidder was Forsythe Bothers. His recommendation was to award the Base Bid and Alternate Bid B. Discussion was held. Motion to award construction contract to Forsythe Brothers for Base, Alternate B and Alternate E with a contingency of 3% was made by Rebecca Davies. Motion died for lack of a second. Motion to award construction contract to Forsythe Brothers for Base Bid and Alternate B Bid for a total of \$324,668.70 was made by Councilmember Davies. Seconded by Councilmember Burrell. Vote: 5 For – 0 Against. Councilmember Turner and Councilmember Snowden were absent for the vote.

Motion to authorize Tom Bolt to authorize change orders up to 3% of the total bid amount was made by Councilmember Davies. Seconded by Councilmember Cruz. Vote: 5 For – 0 Against. Councilmember Turner and Councilmember Snowden were absent for the vote.

Councilmember Turner and Councilmember Snowden returned to the meeting at 8:15.

7. Engineer's report on Manor Police Station Building project.

Frank Phelan, City Engineer gave an update to Council on the Manor Police Station Building.

8. Consideration, discussion and possible action regarding a shooting range for the Manor Police Department. Item requested by Councilmember Burrell.

Motion to postpone for a year was made by Councilmember Burrell. Seconded by Councilmember Turner. Vote: 7 For – 0 Against.

Consideration, discussion and possible action to approve a contract with TLC Office Systems for copier services.

Motion to approve the contract with TLC Office Systems for copier services was made by Councilmember Hooker. Seconded by Councilmember Snowden. Vote: 7 For - 0 Against.

10. Consideration, discussion and possible action to approve a resolution to apply for the Edward Byrne Memorial Justice Assistance Grant.

Motion to approve a resolution to apply for the Edward Byrne Memorial Justice Assistance Grant was made by Councilmember Davies. Seconded by Councilmember Cruz. Vote: 7 For – 0 Against.

11. Consideration, discussion and possible action to approve an Interlocal Agreement for Plumbing Inspections within the ShadowGlen Subdivision.

Motion to approve an Interlocal Agreement for Plumbing Inspections within the ShadowGlen Subdivision was made by Councilmember Turner. Seconded by Councilmember Davies. Vote: 7 For – 0 Against.

12. Consideration, discussion and possible action to conduct the First and Second Readings on the proposal to approve an ordinance granting to Atmos Energy corporation, a Texas and Virginia corporation, its successors and assigns, a franchise to construct, maintain, and operate pipelines and equipment in the City of Manor, Travis County, Texas, for the transportation, delivery, sale, and distribution of gas in, out of, and through said city for all purposes; providing for the payment of a fee or charge for the use of the public rights-of-ways; and providing that such fee shall be in lieu of other fees and charges, excepting ad valorem taxes; and repealing all previous gas franchise ordinances.

Item will be postponed until next meeting. No action was taken.

13. Consideration, discussion and possible action on proposed city charter amendments.

Motion to approve the proposed charter amendments for the May election was made by Councilmember Davies. Seconded by Councilmember Cruz. Vote: 2 For - Councilmembers Davies and Cruz – 5 Against - Councilmembers Hooker, Burrell, Snowden, Turner and the Mayor.

Motion to postpone until Tuesday, February 24th at a Special Meeting was made by Councilmember Turner. Seconded by Councilmember Hooker. Vote: 7 For – 0 Against.

14. Consideration, discussion and possible action to approve an ordinance calling the May 9, 2015 Special Election to submit proposed city charter amendments to the voters.

Motion to postpone until Tuesday, February 24^{th} at a Special Meeting was made by Councilmember Turner. Seconded by Councilmember Hooker. Vote: 7 For -0 Against.
