3. Consideration, discussion, and possible action on acceptance of the unaudited November, 2015 Monthly Financial Report.

Motion to accept the financial monthly report as presented was made by Council Member Snowden. Seconded by Council Member Kruppa. Vote: 6 For – 0 Against.

4. Consideration, discussion, and possible action on a request to waive the building permit and inspection fees for Travis County ESD #12 for remodeling of the fire station on Parsons Street.
