He also stated that he had been approached by a citizen to rent the building for an antique shop. He also gave Council an update on the brown water issue in Stonewater. The City tested the water immediately and the water was safe to drink. Finally, Mr. Bolt stated the he, along with some member of the Police Department, participated in the Black History Month Program at the Rural Center.
