#### **WATER BILL**

Water bills are due on the **15**<sup>th</sup> of each month **before 5pm**. A 10% penalty is applied to all bills not paid before 5pm. This applies to all payments made in office, automated, and online – all must be paid before 5 pm to avoid penalty.

Bills that are not paid **by 5pm** on the **25**<sup>th</sup> of each month are subject to service disconnection and a \$50 penalty fee regardless of service interruption. This applies to all payments made in office, automated, and online – all must be paid before 5 pm to avoid disconnection.

Payments on the utility bill can be made in office by cash, checks, money orders, or Mastercard/Visa. There is a \$2 credit card fee to pay with a credit card.

There are several ways to pay the utility water bill:

- You can make payments via our automated phone line by dialing (512) 272-5555 Ext. 2 or by dialing (833) 646-2633 directly. There is a \$2 credit card fee to pay with a credit card.
- You can register your account and pay online via our website, <a href="www.manortx.gov">www.manortx.gov</a>. There is a \$2 credit card fee to pay with a credit card.
- You can enroll in Auto Draft with us. We will draft your bill directly from your bank account on the 15<sup>th</sup> of the month.

#### **TRASH**

Sky blue bin = Recyclable items

Green bin = Household Trash

Trash pick-up days:

Monday - Greenbury Village, Bell Farms, Carriage Hills, and Village at Manor Commons Tuesday - Stonewater, Presidential Glen, Presidential Heights, and Carillon- Phase 1 Wednesday - Downtown, Wildhorse Creek, Hamilton Point, and Lagos Thursday - Carillon- Phase 2, Shadowglen

- Place bins out by 7 am on service day. Place carts at least 5 feet apart from each other.
- Do not place carts closer than 10 feet from a parked vehicle, mailbox or any large item.
- Recycle is only picked up every other week on your scheduled recycle pick up day.
- Cart lids MUST be closed at time of collection.
- All issues must be reported to Waste Connections.

#### Acceptable Items for Recycling

**Paper**: including newspapers, magazines, white and colored office paper, soft cover books, card stock, junk mail, file folders, self-adhesive notes, envelopes, cardboard, food, and beverage boxes, wrapping paper, catalogs, and phone books.

**Rigid Plastics #1-5 And 7**: includes bottles containing water, soda, beverages, liquid, soap, and alcohol. Containers must be free of food residue.

**HDPE Natural #2**: Typically consists of milk and water jugs.

**HDPE Colored #2**: Typically consists of any pigmented or solid-colored HDPE bottles or jugs that contain liquid such as detergent, fabric softener, lotion, antifreeze, or shampoo.

**PET #1**: consists of clear or tinted transparent bottles or jugs. They may be tinted blue, green or brown. For example, bottles that contain water, soda, cooking oils, mouthwash and alcohol are acceptable.

Rigid Plastic Containers #4, 5, 7: including yogurt and margarine tubs.

**Aluminum Cans**: consists of aluminum beverage container only.

**Steel Cans**: consists of steel cans for food which must be rinsed out.
