With a quorum of the Council Members present, the regular session of the Manor City Council was called to order by Mayor Rita G. Jonse at 7:00 p.m. on Wednesday, September 5, 2018, in the Council Chambers of the Manor City Hall, 105 E. Eggleston St., Manor, Texas.

MOTION: Upon a motion made by Council Member Shaner and seconded by Council Member Amezcua, the Council voted seven (7) For and none (0) Against to close the Public Hearing. The motion carried unanimously.

10. Conduct the first public hearing on the FY 2018-2019 Proposed Property Tax Rate of the City of Manor, Texas.

The City staff's recommendation was that the City Council conduct the public hearing.

Lydia Collins, Director of Finance, was available to address any questions posed by the City Council.

Mayor Jonse opened the public hearing.

City Manager Bolt discussed the FY 2018-2019 Proposed Property Tax Rate.

MOTION: Upon a motion made by Council Member Weir and seconded by Council Member Amezcua, the Council voted seven (7) For and none (0) Against to close the Public Hearing. The motion carried unanimously.

11. Conduct a public hearing regarding the annexation of 24.00 acres of land, more or less, adjacent and contiguous to the city limits and being located in the James Manor Survey No. 39, Abstract No. 528, James Manor Survey No. 40, Abstract No. 566, and Calvin Barker Survey No. 38, Abstract No. 58, City of Manor, Travis County, Texas.

The City staff's recommendation was that the City Council conduct the Public Hearing.

Scott Dunlop, Planning Coordinator, was available to address any questions posed by the City Council.

Mayor Jonse opened the public hearing.

MOTION: Upon a motion made by Council Member Hill and seconded by Council Member Pierson, the Council voted seven (7) For and none (0) Against to close the Public Hearing. The motion carried unanimously.

The motion carried unanimously.

12. Consideration, discussion, and possible action on Change Order No. 1 for the 2017 Paving Improvements Project.

The City staff's recommendation was that the City Council approve the proposed Change Order No. 1 for the 2017 Paving Improvements Project.

City Engineer Phelan discussed the Change Order for the 2017 Paving Improvements Project regarding the addition of E. Browning Street to the project.

The discussion was held regarding the funds for the project.

Council Member Kruppa inquired about the distance of the road. City Engineer Phelan stated he estimated 300 feet.

The discussion was held regarding the timeline of the project and notifications to nearby residents regarding the construction.

MOTION: Upon a motion made by Council Member Kruppa and seconded by Council Member Weir the Council voted seven (7) For and none (0) Against to approve the proposed Change Order No. 1 for the 2017 Paving Improvement Project. The motion carried unanimously.

Johnny Sanders, 156 Spring Branch, Bastrop, Texas, spoke before City Council regarding the waiver request for the installation of utility and service lines to allow for above ground services along the northside of Tower Road adjacent to the Presidential Heights subdivision.

Mr. Sanders stated Bluebonnet Electric was never notified of the ordinance change. He is requesting for the approval of the variance.

The discussion was held regarding the postponed Council meetings back in March of 2018 to give Bluebonnet an opportunity for feedback regarding the ordinance change.

City Manager Bolt stated the ordinance was legally published and posted.

The discussion was held regarding the type of line system in place for the development.

The discussion was held regarding the current above ground service lines along Tower Road in the Stonewater Subdivision.

MOTION: Upon a motion made by Council Member Kruppa to approve the waiver from Manor Code of Ordinances, Chapter 13, Article 13.01, Section 13.01.002(a) Installation of Utility and Service Lines to allow for above ground services for approximately 2,171 feet along the northside of Tower Road adjacent to the Presidential Heights subdivision. The motion failed for lack of second.

MOTION: Upon a motion made by Council Member Pierson and seconded by Council Member Hill the Council voted six (6) For and one (1) Against to deny waiver from Manor Code of Ordinances, Chapter 13, Article 13.01, Section 13.01.002(a) Installation of Utility and Service Lines to allow for above ground services for approximately 2,171 feet along the northside of Tower Road adjacent to the Presidential Heights subdivision. Council Member Kruppa voted against. The motion carried.
