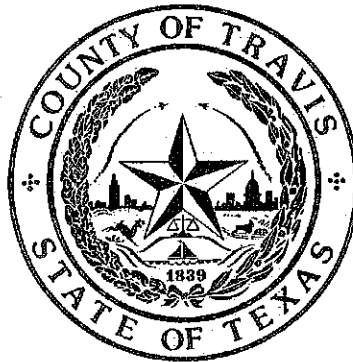

**ORDINANCE NO. 561**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION OF THE CITY OF MANOR HELD ON TUESDAY, NOVEMBER 5, 2019, FOR THE CITY OF MANOR'S MAYOR; COUNCIL MEMBER PLACE NO. 1; COUNCIL MEMBER PLACE NO. 3; AND COUNCIL MEMBER PLACE NO. 5; AND DECLARING THE EFFECTIVE DATE OF THIS ORDINANCE.**

Whereas, pursuant to the Texas Election Code, the City Council of the City of Manor, Texas, convened on this the 18<sup>th</sup> day of November 2019 at 7:00 p.m. for canvassing the vote in the General Election held on November 5, 2019.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, THAT:**

Section One. Canvass of Vote. There came to be considered the returns of the general election held on the 5<sup>th</sup> day of November 2019, for electing one Mayor and three (3) Council Members, and it is appearing from said returns, duly and legally made, that there were cast at said election 594 votes (*total votes*); and that each of the candidates in said election received the following votes:

Section Two. Finding and Declarations. It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Dr. Larry Wallace Jr. was duly elected to Mayor; Emily Hill was duly elected to the City Council, Place 1; Dr. Christopher Harvey was duly elected to the City Council, Place 3; and, Deja Hill was duly elected to the City Council, Place 5. Said above named parties are hereby declared duly elected to said respective offices, subject to taking of their oaths of office as provided by the laws of the State of Texas.

Section Three. Open Meetings. It is further found and determined that in accordance with this Ordinance of this governing body that the City Secretary posted written notice of the date, place and subject of this meeting in the bulletin board of the City Hall, a place convenient to the public, and said notice having been so posted continuously for at least 72 hours preceding the date of this meeting. A copy of the return of aid posting shall be attached to the minutes of the meeting and shall be made a part thereof for all intents and purposes.
