- **MOTION:** Chairperson Wissmann motioned to revise minutes with correction to her last name. Commissioner Hay seconded. Vote called by Chairperson Wissmann to approve. Charter Review Commission voted five (5) For and none (0) Against. The motion carried.

2. Discussion of Charter Review Commission meeting schedule.

- MOTION: Commissioner Hay motioned to table Section 1.06, Power of Eminent Domain. Commissioner Benitez seconded. Vote called by Chairperson Wissmann to approve. Charter Review Commission voted six (6) For and none (0) Against. The motion carried.

- **MOTION:** Commissioner Gamez motioned to change term limit from two (2) years to three (3), for all Council Members and Mayor. Chairperson Wissmann seconded. Vote called by Chairperson Wissmann to approve. Charter Review Commission voted four (4) For and one (1) Against. The motion carried.
- **MOTION:** Commissioner Hay motioned to remove the last two sentences on Section 3.02, Term Limitations. Commissioner Benitez seconded. Vote called by Chairperson Wissmann to approve. Charter Review Commission voted four (4) For and one (1) Against. The motion carried.
- **MOTION:** Commissioner Gamez motioned for Council Members and Mayor to be able to serve no more than five (5) terms. Commissioner Hay seconded. Vote called by Chairperson Wissmann to approve. Charter Review Commission voted four (4) For and one (1) Against. The motion carried.
