The following items must accompany your signed application:

- 1. A copy of your driver's license front and back (not a Commercial Driver's License [CDL]; and,
- 2. A copy of Current proof of vehicle insurance; and,
- 3. Payment of court required fees: \$144.00 (Non-School Zone) OR \$179.00 (School Zone):
 - Online requests Call the court at 512-272-8178 to pay over the phone with a Visa or MasterCard (\$3 fee applies effective 1/15/2024).
 - Mailed requests Money order or cashier's check made payable to the "City of Manor". Must be post marked no later than the initial appearance date indicated on citation.
- 4. Include the citation number(s) to ensure proper processing.

You are **NOT ELIGIBLE** to take Driver Safety Course to dismiss a ticket if:

- You have completed a driving safety course within the 12 months preceding the date of the offense; and,
- You are a holder of a CDL (Commercial Driver's License); and,
- You were speeding 25 miles or more over the limit or in excess of 95 m.p.h.; and,
- You were charged with these specific offenses:
 - Passing a school bus
 - Offense in a construction or maintenance work zone when workers were present
 - Leaving the scene of an accident; and,
- You do not have a Texas Driver's License.
