# REGULAR AGENDA (discussion and action items)

 Discussion and possible action to Amend Ordinance 185-H to include Food Court (Food Trailers) as a conditional use, and to establish minimum standards and/or conditions for approval. Staff: Thomas Bolt, Director of Development Services.

Director of Development, Tom Bolt, requested Council postpone this item until further notice. City Council agreed to postpone and took no further action.

4. Discuss, consider and act upon an amendment to the Presidential Glen Subdivision Development Agreement Exhibit F, 3(c) Owner: Presidential Glen, L.I.D., Dwyer Realty Corporation. Staff: Thomas Bolt, Director of Development Services.

A motion was made by Council Member Burrell and seconded by Council Member Hooker to amend the Presidential Glen Subdivision Development Agreement, Exhibit F, 3(c) with revisions to the minimum living areas and the percentage of total lots allowed under those revised areas as requested by the developer. The motion carried unanimously.
