ORDINANCE NO. 401

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE MAY 12, 2012, GENERAL ELECTION OF THE CITY OF MANOR, TEXAS.

Whereas, pursuant to the City Charter and Texas Election Code, the City Council of the City of Manor, Texas, convened on this the 23rd day of May 2012, at 12:00 p.m. for the purpose of canvassing the vote in the general election held on May 12, 2012.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, THAT:

Section Onc. <u>Canvass of Vote</u>. There came to be considered the returns of the general election held on the 12th of May, 2012, for the purpose of electing Council Members for Places Two and Four and it appearing from said returns, duly and legally made, that there were cast at said election 142 votes; and that each of the candidates in said election received the following votes:

Section Two. Finding and Declarations. It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and Gil Burrell as duly elected to the City Council Place 2, Danny Scarbrough as duly elected to the City Council Place 4. Said above named parties are hereby declared duly elected to said respective offices, subject to taking of their oaths of office as provided by the laws of the State of Texas.

Section Three. Open Meetings. It is further found and determined that in accordance with this Ordinance of this governing body that the City Secretary posted written notice of the date, place and subject of this meeting in the window of the City Hall, a place convenient to the public, and said notice having been so posted continuously for at least 72 hours preceding the date of this meeting. A

copy of the return of said posting shall be attached to the minutes of the meeting and shall be made apart thereof for all intents and purposes.
