REGULAR SESSION – 6:30 P.M.

With a quorum of the Board of Adjustment (BOA) present, the regular session of the Manor Board of Adjustment was called to order by Chairperson Moreno at 6:33 p.m. on Wednesday, February 26, 2020, in the Council Chambers of the Manor City Hall, 105 E. Eggleston Street, Manor, Texas.

PUBLIC COMMENTS

No one appeared to speak at this time

CONSENT AGENDA

1. **Consideration, discussion, and possible action on the January 22, 2020 Board of Adjustment Minutes**

MOTION: Upon a motion made by Board Member Sulcer and seconded by Board Member Mazarac the Board of Adjustment voted four (4) For and none (0) Against to approve the January 22, 2020 Board of Adjustment Minutes. The motion carried unanimously.

PUBLIC HEARINGS

2. **Public Hearing:** Conduct a public hearing on a variance request from Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 34(b)(iv)(C) and Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 20(m) for 14.22 acres of land more or less and located at 12601 US Hwy 290 E, Manor, TX, to reduce the required number of parking stalls to 1.8 stalls per unit. Applicant: Development Engineering Consultants, LLC. Owner: The Grassdale at Manor, LLC

Chairperson Moreno opened the public hearing.

No one appeared to speak.

MOTION: Upon a motion made by Board Member Mann and seconded by Board Member Mazarac the Board of Adjustment voted four (4) For and none (0) Against to close the Public Hearing. The motion carried unanimously.

REGULAR AGENDA

3. **Consideration, discussion and possible action on a variance request from Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 34(b)(iv)(C) and Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 20(m) for 14.22 acres of land more or less and located at 12601 US Hwy 290 E, Manor, TX, to reduce the required number of parking stalls to 1.8 stalls per unit. Applicant: Development Engineering Consultants, LLC. Owner: The Grassdale at Manor, LLC**

John Taylor, Callaway Architecture, 1207 Hampshire Lane, Richardson, TX 75080 recorded his support for this item.

Staff explained that this request had been made before on other project and granted by the City Council and Board of Adjustment. As a result of the approved variances the parking requirements were amended by City Council to allow a 1.8 ratio depending on the unit mix. Staff further clarified this project was applied for while the previous code was still in effect and still subject to the previous rules.

Board Member Sulcer asked the applicant the applicant about the number of spaces provided

Mr. Taylor explained they are requesting to go to 1.8 spaces per unit minimum and they will be have a couple additional spaces above that minimum

Board Member Mazarac said that if each 1 bedroom had 2 people the project would need 684 spaces and asked how this request was approved before

Staff answered that prior to the Board of Adjustment forming the City Council had granted a waiver and after the Board was formed in October they granted a request

Board Member Mazarac expressed concern that the project would be under-parked

Mr. Taylor said most places have 1.8 spaces per unit and it's very common

Board Member Mann asked how many guest parking spaces there would be

Mr. Taylor said the guest parking was included in the 1.8 per unit total, that there would not be separate guest only parking and parking would be within the gate area.

Staff explained how much parking would be required under the previous code


MOTION: Upon a motion made by Board Member Mann and seconded by Chairperson Moreno the Board of Adjustment voted three (3) For and one (1) Against to approve a variance request from Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 34(b)(iv)(C) and Manor Code of Ordinances, Chapter 14, Exhibit A, Article II, Section 20(m) for 14.22 acres of land more or less and located at 12601 US Hwy 290 E, Manor, TX, to reduce the required number of parking stalls to 1.8 stalls per unit.. The motion failed with Board Member Mazarac voting Against.

With no business remaining, Chairperson Moreno adjourned the Regularly Scheduled Board of Adjustment meeting at 6:50 PM.
