INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED. Application for a permit to operate does not guarantee that a permit will be granted. Permit approval is based upon the establishment or mobile food unit's compliance with state and local health requirements. In the event a permit is not issued, the permit fee may be refunded. No permit refunds for any reason after 180 days from receipt of payment. PERMITS ARE NON-TRANSFERABLE.

## Permit types:

Door to door vendor - Peddlers or Solicitors who sell goods or services from place to place for immediate or future delivery.

Open air vendor - Peddlers or Solicitors who sell goods or services at fixed location from a vehicle, cart, stand, tent or other structure

Semi-permanent food vendor - operate at a fixed location from a trailer, stand, or building that does not allow access inside to customers

Mobile food vendor - operate from a vehicle or portable structure and do not remain in one location for more than 2 weeks

Temporary food establishment - food service at a location for no more than 14 days in conjunction with an organized event or celebration
