Recognizing National Police Week 2020 and honoring the service and sacrifice of those law enforcement officers killed in the line of duty while protecting U.S. communities and safeguarding our democracy.

**WHEREAS**, there are approximately 800,000 law enforcement officers serving in communities across the United States, including all dedicated **MANOR PEACE OFFICERS**; and

**WHEREAS**, since the first recorded line of duty death in 1786, 22,000 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty; and

**WHEREAS**, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, D.C.; and

*WHEREAS*, 307 names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 135 officers killed in 2019, and 172 officers killed in previous years; and

WHEREAS, of the 135 officers killed in 2019 on average left behind two children; and

**WHEREAS**, Texas and municipalities were second in the nation with the most officer fatalities; and

*WHEREAS*, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 32nd Annual Candlelight Vigil, on the evening of May 13, 2020 in the Nation's Capital.

# **Public Works Department**

# Street and Public, Parks, and Maintenance Department

In the month of April, the Public Parks and Maintenance Department mowed all city facilities, alleys, and right of ways. They cleaned and maintained all city's facilities and parks. They performed all maintenance on city vehicles and heavy equipment. In April, the Street Department repaired streets, curbs and signs.






# Proposed Rezoning: Neighborhood Business (NB)

The proposed project budget is \$40,404.12 and will be applied to officer overtime and supplies, equipment, and contracts related to the response to COVID-19.

Federal Funds are authorized under Division B of H.R. 748, Pub. L. No. 116136 (Emergency Appropriations for Coronavirus Health Response and Agency Operations); 28 U.S.C. 530C. CESF funds are made available through a Congressional appropriation to the U.S. Department of Justice, Bureau of Justice Assistance. All awards are subject to the availability of appropriated federal funds and any modifications or additional requirements that may be imposed by law.

Texas expects to make approximately \$37.8 million available to local units of government through regionally based allocations using the Regional Councils of Governments boundaries. The CAPCOG region has been allocated \$2,787,712.
