STATE'S STANDING MOTION TO DISMISS CERTAIN VIOLATIONS

To the Honorable Judge of Said Court,

Comes now, the State of Texas, by and through its prosecuting attorney, and respectfully asks this Court to dismiss certain citations for the below violations upon presentation of the applicable evidence.

Failure to Maintain Financial Responsibility, Transportation Code 601.051, 601.053, 601.191 & 601.195 – The State hereby moves that upon presentation of evidence showing that the defendant and/or vehicle were covered at the time of the alleged offense and upon verification, the Court shall dismiss those citations.

Failure to Display Driver's License, Transportation Code 521.025 – The State hereby moves that upon presentation of evidence showing that the defendant possesses a driver's license issued to that person, appropriate for the vehicle operated and valid at the time of the alleged offense, the Court shall dismiss those citations.

Failure to Display Disabled Placard, Transportation Code 681.011 – The State hereby moves that upon presentation of evidence showing a disabled parking license plate or placard issued to a defendant and/or the vehicle operated on the date of the alleged offense which was valid on the date of the alleged offense, the Court shall dismiss those citations.

No Animal License, Manor Code of Ordinance Chapter 2 Sec. 2.02.004 – The State hereby moves that upon presentation of a valid animal registration receipt from the City of Manor, evidencing registration of the animal for which the citation was issued by the defendant's initial appearance date, the Court shall dismiss those citations.

No Rabies Vaccination, Manor Code of Ordinance Chapter 2 Sec. 2.02.001 – The State hereby moves that upon presentation of a valid certificate from a licensed veterinarian evidencing vaccination of the animal for which the citation was issued for rabies by the defendant's initial appearance date, the Court shall dismiss those citations.

No Alarm Permit, Manor Code of Ordinance Chapter 4 Sec. 4.05.032 – The State hereby moves that upon presentation of a valid alarm permit evidencing that the permit was obtained on or before the initial appearance date and was a first time offense, the Court shall dismiss those citations.

No Driver's License, Transportation Code 521.021(b) – The state herby moves that upon presentation of evidence showing a valid and effective driver's license issued to a defendant, valid at the time of the violation, the court shall dismiss those citations.

The State further respectfully requests that this Standing Motion be uniformly applied to all such cases described herein. Wherefore, the State of Texas, by an through its prosecuting attorney, prays that this Court order all cases subject to this Standing Motion be dismissed for the above-stated reasons.
